- If you are using the AlterG Anti-Gravity Treadmill, you are doing so at your own discretion, and you agree that you are fit enough to run, walk or otherwise use the equipment.
- You understand that physical activity including running and walking come with inherent risks, and injury may occur during your use of the AlterG Treadmill. SOL is not liable if injury occurs.
- All clients using the AlterG without assistance must be trained to enter/exit the machine safely.
- When you schedule AlterG use, the time is strict. If you arrive late, you are welcome to use the AlterG for the remainder of your appointment, but **we cannot accommodate late appointments.**
- **All cancellations must be made with 24 hours notice or more.** No-shows and late cancellations will result in forfeit of full session price.

Free Movement Alter G Clients Understand the Following:

Clients qualify for Free Movement Appointments **if and only if** all of the following are true:

- Clients have been trained to safely enter, exit, and use the Alter G Anti-Gravity Treadmill.
- Clients can enter, exit, and operate the AlterG without any outside assistance.

Free movement clients understand the following:

- You will need to buy your own AlterG shorts after your first visit.
- It is your responsibility to keep track of the timing of your appointment.
- It is your responsibility to ensure you exit the AlterG at or before the end of your appointment.
- If you require more than minimal assistance, we have the right to insist you schedule assisted movement appointments.

Assisted Movement AlterG Clients Understand the Following

Clients qualify for Assisted Movement Appointments **if and only if** all of the following are true:

- Clients need only moderate assistance to enter/exit the machine.
- Once inside the AlterG Clients can operate the user interface and run without assistance.

Assisted movement clients understand the following:

- You will need to buy your own AlterG shorts after your first visit.
- You can only schedule appointments between 9a – 5p, Monday – Friday.
- Appointments must be scheduled the same day or the next day to ensure assistance is available.
- If, at any point, you are able to use the AlterG without assistance, you can move to SOL’s Free Movement AlterG program.

Therapeutic Movement Clients Understand the Following:

- 30 Minute sessions include time it takes to enter/exit the AlterG.
- Because sessions are booked with a SOL Physical Therapist, the standard SOLPT \$65 fee applies when you are late, no-show, or do not cancel your appointment with more than 24 hours notice.
- You have booked the AlterG **only** for the 30 minutes indicated. **Late arrivals cannot be accommodated.**
